In respect of item No.1 of Agenda Point I (Forest Deptt.), the Secretary Law Department opined that since there is already an act called the State Pollution Control Act in force, which also provides for a specific time frame for issuance of the said NOC, therefore, the inclusion of this service within the ambit of the J&K Public Service Guarantee Act,2011 can give rise to complications. In view of this, it was decided that the proposal of the Forest Department for inclusion of the said service within the PSGA be deferred as the same needs further examination.
- 2. The proposal with regard to item Nos.1 & 2 of Agenda Point II (Transport Deptt.) was approved without any change.
- 3. In respect of item No.1 of Agenda Point III (Public Works(R&B)Deptt.) the Department proposed Superintendent Engineer(SE) to be the Designated Officer in place of the Executive Engineer proposed earlier.

4. With respect to item No.2 of Agenda Point III, the proposal was approved without any change.
