It is further ordered that:

- (i) The concerned Administrative Departments shall issue orders regarding their posting in such a manner that they are able to join their new places of postings on the specified dates;
- (ii) during their posting, these probationers shall discharge all the functions attached to the said posts;

- (iii) during the deployment of the Junior Scale KAS probationers as Tehsildars, the powers of Executive Magistrate 1st Class shall be conferred on these probationers by the Department of Law, Justice and Parliamentary Affairs, with whom the matter shall be taken up in advance by the Revenue Department;
- (iv) immediately after completion of the 'On the Job Practical Training', the concerned Administrative Secretaries shall issue a performance/ work done certificate in respect of these probationers; and
- (v) during the period of their "On-the Job Training", the salary of these probationers shall be drawn and disbursed by the General Administration Department, subject to production of the attendance certificate.

Advance T.E, as admissible under rules, is also sanctioned in favour of the probationers in whose case change of station is involved.
