The Committee may co-opt an Officer, not below the rank of Additional Secretary to the Government, of the Cadre Controlling Department of the deceased employee or employee retiring on invalid pension during the course of the deliberations on the application of the dependent of the concerned deceased employee or employee retiring on invalid pension.

The Committee shall make recommendations for appointment/monetary compensation on compassionate grounds as per the total points obtained by each applicant under the applicable Relative Merit Points Assessment Scheme as outlined in Annexure-I to the Jammu and Kashmir Rehabilitation Assistance Scheme, 2022.


