Terms of References:-

1. The UT Level Monitoring committee shall implement the NIMC guidelines at the UT level and provide feedback to NIMC.
2. It shall also guide and steer the implementation of the scheme in the Jammu and Kashmir.
3. It shall also examine and approve the selected list of beneficiaries/projects for inclusion in the scheme in consultation with DLMC.
4. It shall set the targets as per Output and Outcome framework format and review the progress regularly.

Terms of References:-

1. District Level Monitoring Committee (DLMC) shall be the first line of implementation and monitoring system within the overall framework.
2. It shall identify the beneficiaries, to ensure viability of the project and prepare viable project reports to support beneficiaries in collaboration with PMU.
3. It shall also examine the proposal(s) and recommend the same to UTLMC for consideration.
4. DLMC shall set targets in consultation with UTLMC as per OOMF format and monitor the progress closely with support of the PMU.
5. DLMC shall maintain the Dashboard in collaboration with the PMU.
6. DLMC shall be responsible for the smooth implementation of the scheme and resolve any issues at the district level. In the process of sorting out implementation issues, the Committee shall be supported by the District Administration wherever required.

The above committees shall also monitor the implementation of other schemes viz- Animal Husbandry Infrastructure Development Fund, Fisheries & Aquaculture Infrastructure Development Fund and National Horticulture Board.
