Subject:- Institution of Tabinda Gani State Award of Bravery for children.

Sanction is hereby accorded to the Institution of State Award of Bravery for Children in the name of "Tabinda Gani" a student of Batapora Langate, Tehsil Handwara who demonstrated exemplary bravery and put up formidable resistance before falling prey to the evil designs of the gangsters on July 20, 2007.

The details of the award shall be as under:-

- (i) The award shall be called as "Tabinda Gani" State Award of Bravery for Children and shall be awarded by the State Government on Independence Day every year.
- (ii) There will be three categories of Bravery Award namely:-
 - i. Bravery Award -Category -I.
 - ii. Bravery Award -Category -II
 - iii. Bravery Award -Category -III

(only one award will be given under each of the above mentioned categories).
- (iii) Only children up to the age of 16 years will be eligible for the Award for Bravery.
- (iv) The act of Bravery in the last 15 months on the date when the nomination is being considered will be taken into account for grant of award.

For Bravery Award category-I

- (v) The award shall consists of a Gold Medal weighing 20 grams (18 K), Rs. 50,000 in cash, a citation and scholarship of Rs. 1000/- per month upto the class the awardee pursues education. This award will be given for conspicuous courage under circumstances of very grave danger to life.

For Bravery Award category-II

- (vi) Gold Medal weighing 20 grams (18 K), Rs 35,000/- in cash, citation and scholarship of Rs. 1000/- per month upto the class the awardee pursues education. This award will be given for courage and promptitude in saving life under circumstances of grave danger to the life of the rescuer.



For Bravery Award category-III


- (vii) Gold Medal weighing 20 grams (18 K), Rs. 25,000/- in cash, citation and scholarship of Rs. 1000/- per month upto the class awardee pursues education. This award will be given for courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer.
- (viii) The award can also be conferred upon posthumously.
- (ix) The General Administration Department shall invite nominations from all Deputy Commissioners/Divisional Commissioners, Jammu/Kashmir for Bravery Awards upto the 30th June every year. XX
- (x) The nominations received by the General Administration Department shall be screened by a Committee comprising the following:-
- a. Chief Secretary.
 - b. Financial commissioner, (Home).
 - c. One other officer not below the grade of Financial Commissioner/Principal Secretary to be nominated by the HCM.
 - d. Administrative Secretary,, GAD.
 - e. Divisional Commissioner, Jammu/Kashmir .
 - f. Inspector General of Police, (CID).

The screening committee shall finalize its recommendations by the 15th July of every year.

- (xi) The recommendations of the Screening Committee shall be considered by the State Award Committee comprising:-
- a. A Cabinet Minister to be nominated by the Hon'ble Chief Minister as Chairman.
 - b. An eminent public servant-serving or retired-to be nominated by the Hon'ble Chief Minister.
 - c. Two eminent persons from any field to be nominated by the Hon'ble Chief Minister.
 - d. Chief Secretary-Member Secretary.

The Committee shall finalize its recommendations by or before the 31st July every year, which shall be placed by the Chief Secretary before the HCM for consideration.
