





SRO 305 - In exercise of the powers conferred by the proviso to section 124 of the Constitution of Jammu and Kashmir State, the Governor hereby directs that for sub-rule (1) of rule (8) of Jammu and Kashmir Administrative Service Rules, 1979 the following shall be substituted:-

- (1) The Selection Committee shall prepare a list of Officers from the Members of the Services mentioned in clause (b) of sub-rule (1) of rule 5, whom it considers on the basis of merit, suitable for appointment to the service:  
Provided that:-
- (i) the eligibility panel of officers submitted by each Department shall not be more than twice the number of vacancies available for the service subject to a minimum of three officers, in case only one slot in KAS is available to a feeding service;
  - (ii) the Selection Committee shall prepare a select list of officers which shall not exceed the number of slots in KAS available to the said service and a waiting list of 20% of the said slots on the date of the meeting of the Selection Committee;
  - (iii) the select list so prepared shall remain valid for a period of one year, from the date, it is framed by Selection Committee.
