In supersession of earlier orders on the subject and pursuant to Government Instructions under rule 31 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, the composition of the Review Committees to review periodically the cases of suspension of officers of the Jammu and Kashmir Administrative Service (KAS) and Jammu and Kashmir Police (Gazetted) Service (KPS) shall be as under:-

- i. officers of different Departments placed under suspension for their alleged involvement in the Vigilance cases;
- ii. non-gazetted officials involved in a vigilance case, if they belong to more than one Department;
- iii. employees both gazetted and non-gazetted who have been placed under suspension for allegedly possessing assets disproportionate to their known sources of income.
