Whereas, Mr. Krishan Raj Kant S/o Late Sh. Man Singh R/o H. No. 273, Muthi had filed a Service Writ Petition No. 470 of 2019, before the Hon'ble High Court of Jammu and Kashmir at Jammu making therein a prayer for issuance of a direction to respondents to provide the pay protection and other related service benefits in favour of the employees who have been appointed for the post of (10+2) Lecturer advertised vide Notification No. 09-PSC (DR-P) of 2016 dated 19.03.2016 of JKPS; and

Whereas, the Service Writ petition No. 470 of 2019 was transferred by the Hon'ble Court to the Hon'ble Central Administrative Tribunal on 17.06.2020; and

Whereas, the Transferred Application No. 304 of 2020 has been disposed of by the Hon'ble Administrative Tribunal vide Order dated 08.02.2023 with a direction to the Commissioner/Secretary to the Government General Administration Department, to decide the representation moved by the applicants association namely "All In-Service 10+2 Lecturers", School Education Department, Union Territory of Jammu and Kashmir and pass a reasoned and speaking order in accordance with law and before taking such a decision, the applicants shall also be afforded an opportunity of hearing;

Now therefore, in pursuance of the directions passed by Hon'ble Central Administrative Tribunal Jammu Bench, passed vide Order dated 08.02.2023 in T.A No. 61/304/2020 in WP(C) No. 470/2019-titled Krishan Raj Kant and others. vs U.T of J&K and others, Mr. Krishan Raj Kant S/o Late Sh. Man Singh R/o H. No. 273, Muthi, Jammu and also the other applicants including representatives of All In-Service 10+2 Lecturers Association are hereby informed to present themselves along with their claims in writing before the Commissioner Secretary to the Government, General Administration Department on **29.12.2023, at 12:00 (noon) in his office chambers viz. Room No. 2/26, 2nd floor Main Building Civil Secretariat, Jammu**, failing which the decision in the matter shall be decided in ex-parte.
