Subject: Re-fixation of seniority of JKAS officers belonging to J&K Excise and Taxation (Gazetted) Service in the Jammu and Kashmir Administrative Service.

NOTICE

WHEREAS, in pursuance of the recommendations of the Establishment-cum-Selection Committee in its meeting held on 06.12.2010 and subsequent approval of State Cabinet, vide Government Order No: 88-GAD of 2011 Dated: 14.01.2011, the following members of J&K Excise and Taxation (G) Service were appointed (by promotion) into Time Scale of JKAS, prospectively w.e.f. 14.01.2011 :

1. Abdul Qayoom Ahanger
2. Pawan Kumar (RBA)
3. Bharat Singh (RBA-PHC)
4. Mansoor Aslam Choudhary (ST)

AND WHEREAS, while fixing seniority of officers appointed into the Time Scale of JKAS from 01.01.2009 to 31.12.2011, vide Government Order No. 784-GAD of 2014 dated 18.07.2014, these officers were assigned seniority alongwith other members inducted into the Time Scale during 2011 in terms of the extant rules;

AND WHEREAS, these officers represented in the General Administration Department for review of their appointment from 14.11.2010 i.e. from date when they were recommended by the ECSC for their appointment into the Time Scale instead of from 14.01.2011;

AND WHEREAS, the Establishment-cum-Selection Committee in its meeting held on 19.02.2015, considered the request made by these officers and inter-alia, recommended as under:-

- (i) modification in the appointment of these officers to the Time Scale of KAS w.e.f. 6.12.2010 i.e. the date when they were recommended by the Establishment-cum-Selection Committee for being inducted into the Time

Scale of KAS, instead of from 14.1.2011 when they have been appointed.

- (ii) re-fixation of the seniority of the in-service officers in the seniority list of JKAS officers, issued vide Government Order No. 784-GAD of 2014 dated 18.7.2014.

AND WHEREAS, upon acceptance of above recommendations of the ECSC by the State Cabinet, vide Government Order No. 569-GAD of 2015 dated 19.4.2015, the appointment of these officers to the Time Scale of JKAS, was modified and given effect from 6.12.2010 instead of 14.1.2011 ;

AND WHEREAS, as a consequence of modification in the appointment of these officers to the Time Scale, their seniority position is to be re-fixed in the seniority list of JKAS;

AND WHEREAS, on the basis of merit and seniority position in the parent departmental feeding service i.e. J&K Excise & Taxation (G) Service and in terms of Rule 18 of JKAS Rules, the seniority position of these officers is to be re-fixed in Government Order No. 784-GAD of 2014 dated 18.07.2014, in the following manner:-
