Grant of Lieutenant Governor's Award for Honesty, Integrity & Meritorious Public Service - inviting of nominations for the year, 2023.

Subject: Institution of Hon'ble Chief Minister's Gold Medal for Integrity and Meritorious Public Service.

60vernment Order No: 860 -6AD of 2006 Dated: 12- 07- 2006

Sanction is hereby accorded to the institution of Hon'ble Chief Minister's Gold Medal for Integrity and Meritorious Public Service as per the following scheme:-

- (i) Hon'ble Chief Minister's Gold Medal for Integrity and Meritorious Public Service shall be awarded by the Hon'ble Chief Minister, J&K, on the Independence Doy (15th August) every year;
- (ii) The award shall consist of a Gold Medal weighing 30 gms of 22 carats, a cash prize of Rs.1.00 lakh (Rupees one lakh only), a citation and a certificate.
- (iii) The award shall be given without distinction of position held by a public servant in any Department/ Public Sector Undertaking/ Corporation/ Society/ Board of the State Government.
- (iv) The number of awards to be given on each Independence Day shall not be more than five unless specifically authorized by the Hon'ble Chief Minister.
- (v) General Administration Department shall invite nominations from Administrative Departments for Chief Minister's Gold Medal to be received latest by 31st May of every year. If 31st May happens to be a public holiday, in that event, the nominations can be received up to the next working day following 31st May. For 2006 awards, the nominations may be invited up to 25th July, 2006.

- (vi) The concerned Administrative Departments shall recommend for Chief Minister's Gold Medal only such officials who have rendered extraordinary public service or shown outstanding achievements in the task assigned and demonstrated exceptional integrity and honesty. The recommendation will be made in the proforma forming Annexure "A" to this order.
- (vii) The nominations received by the General Administration
 Department shall be screened by a Committee comprising
 the following:-
 - (a) Chief Secretary
 - (b) Financial Commissioner (Home)
 - (c) One other officer not below the grade of Financial Commissioner/Principal Secretary to be nominated by the HCM.
 - (d) Commissioner/Secretary to Government, GAD
 - (e) Vigilance Commissioner;
 - (f) Additional DG, CID

The Screening Committee shall finalize its recommendations by 20^{th} July of every year.

- (viii) The recommendations of the Screening Committee shall be considered by the Independence Day Awards Committee comprising:-
 - (a) A Cabinet Minister to be nominated by the Hon'ble Chief Minister as Chairman.
 - (b) An eminent public servant serving or retired to be nominated by the Hon'ble Chief Minister,
 - (c) Two eminent persons from any field to be nominated by the Hon'ble Chief Minister.
 - (d) Chief Secretary Member Secretary.

The Committee shall finalize its recommendations by or before 31st July, which shall be placed by the Chief Secretary before the HCM for consideration.

(ix) The awards shall be announced by the Hon'ble Chief Minister on the Independence Day and may be given away by him at an Investiture Ceremony to be organized by

Government order No 1/7₀GAD of 2009 Dated: 2009

In continuation of Government Order No.860-GAD of 2006 dated 12-07-2006, it is hereby ordered that the following criteria / norms are hereby laid down for short listing of the officers by the Screening Committee for consideration of the Awards Committee for the Chief Ministers Gold Medal for Honesty / Integrity and Meritorious Public Service:

- The Officer should have completed minimum 20 years in active service so as to enable the Committee to take a more realistic and holistic view about the performance and integrity of the officer;
- The recommendation should be supported by the Administrative Department concerned along with the APRs of the officer for a period of ten years;
- 3 The recommendations should be accompanied by self-contained citations from the sponsoring Departments highlighting the specific achievements of the officer in different assignments over his/he. career span. The proforma as devised for the purpose vide Government order No. 860-GAD of 2006 dated 12-07-2006 shall also be submitted duly filled up;
- 4. The performance of the officer should consistently have been of an extremely high standard and he or she should have done work which, by all standards, is of an exemplary nature. His / her performance and achievements should also be duly reflected in the APRs. The contribution made by the officer to public service should be visible and should have resulted in

- a distinct improvement to the quality of services provided by the Government to the people;
- 5. The integrity of the officer should be impeccable, and he / she should enjoy an overall good public reputation as well, which should be duly verified / certified to be so by the State Vigilance Organization / CID and the Administrative Department concerned.
