**WHEREAS**, the J&K Services Selection Board vide communication No.SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 among others, has forwarded the selection of Mr. Radhey Raman Dogra S/o Jagan Nath Dogra R/o Ward No. 8, Akhnoor Jammu figuring at S.No. 3281 of the select list for the post of MTS (Orderly) in the J&K Secretariat (Subordinate) Service; and


**WHEREAS**, vide Government Order No. 1292-JK(GAD) of 2022 dated 29.10.2022 among others the appointment order was issued in favour of the candidate under SC Category and candidate has joined in the General Administration Department on 01.11.2022; and

**WHEREAS**, Mr. Radhey Raman Dogra S/o Jagan Nath Dogra R/o Ward No. 8, Akhnoor Jammu, appointed as Multitasking Staff (Orderly) in the J&K Secretariat (Subordinate) vide Government Order No. 1292-JK(GAD) of 2022 dated 29.10.2022, represented in the department that his name is actually Radhe Raman Dogra instead of Radhey Raman Dogra and requested for making the necessary correction by deleting the alphabet "y" therein; and

**WHEREAS**, vide letter No. GAD/23/2022-09-GAD(Estt.) dated 20.12.2022 readwith letter dated 24.03.2023, the issue was taken up with the J&K Services Selection Board and in response the J&K Services Selection Board vide letter No. JKSSB-ADM/121/2022-03 (E-7068606) dated 22.02.2023 read with letter dated 27.04.2023 has intimated that, as per the available record, Mr. Radhe Raman Dogra, figuring at Serial No. 3281 under SC category, for the Class-IV posts advertised vide Notification No. 01 of 2020 dated 26.06.2020, has inadvertently mentioned name as Radhey Raman Dogra instead of Radhe Raman Dogra while submitting his application form for these posts and has requested to read the name against the candidature of Mr. Radhey Raman Dogra at Serial No. 3281 under SC category, in the selection list, notified for the Class-IV posts, advertised vide Notification No. 01 of 2020 dated 26.06.2020, as Radhe Raman Dogra instead of Radhey Raman Dogra; and
