NOTIFICATION

Jammu, the 26th of December, 2023

Subject: Revised Tentative Seniority List of Section Officers of Heads of the Departments/Offices as it stood on 01.12.2023.

Whereas, vide Notification No. GAD-ESTB/58/2021-09-GAD dated 13.02.2023, a Tentative Seniority list of Section Officers of Heads of Departments/Offices as it stood on 01.01.2023 was notified; and

Whereas, the cases of Section Officers, in respect of whom the concerned departments/offices furnished the desired information, were examined in the General Administration Department and requisite information, in respect of cases where deficiencies were observed, was sought from the concerned departments vide letter dated 13.02.2023; and

Whereas, subsequently, the department received several fresh cases of Section Officers and on examination of these cases it was observed that several Section Officers were promoted a significant period ago, and were recommended for inclusion after inordinate lapse of time. Besides, most of the departments/offices failed to furnish the clarifications/deficiencies as sought by this department; and

Whereas, vide Notification No. GAD-ESTB/58/2021-09-GAD dated 23.05.2023 a final opportunity has been granted to all Heads of Departments to submit the cases of Section Officers of Heads of Departments cadre, whose names are not figuring in the Tentative Seniority lists, within a period of 15 days from the date of issuance of the said notification, with the stipulation that cases received beyond the stipulated period shall not be entertained and the seniority of such Section Officers shall be reckoned at the bottom of the seniority lists for all practical purposes in future; and

Whereas, thereafter many cases were received in the department for inclusion, and on examination, some of the cases were found complete in all aspects however, deficiencies were also observed in most of the cases. Subsequently, vide letter dated 16.10.2023 requisite information, in respect of the cases where clarifications/deficiencies were observed, was sought from the concerned departments with the advice to furnish the same within a period of one week; and

Whereas, despite lapse of considerable time, the clarifications/ deficiencies in respect of several cases have not been received from various Departments/Offices and it has been decided by the authorities not to wait further and to notify the revised tentative Seniority List of Section Officers; and

Whereas, the name(s) of such Section Officers who have been promoted as Administrative Officers or have retired on superannuation or have expired, are required to be excluded from the seniority list.

Now, therefore, a common revised tentative seniority list of Section Officers of the Heads of Departments cadre, as it stood **on 01.12.2023**, forming Annexure to this notification, is hereby circulated among all the Section Officers of Heads of the Departments cadre for information.

Any Section Officer who may not be satisfied with the position assigned to him/her in the common revised tentative seniority list, may submit his/her representation/objections, if any, with documentary proof to the concerned Head of Department within a week's time, who shall forward the same with specific recommendations to the General Administration Department within a period of **15 days** from the date of issuance of this notification. After expiry of the said period, no objection in this regard shall be entertained. Fresh cases for inclusion in the seniority list of Section Officers, if received in future, shall be examined separately.

The date(s) of birth and category status of the officials recorded in the Seniority List shall not be taken as authentic and shall be subject to further verification with the Service book/Matriculation Certificate issued in respect of these officials by the concerned authorities.

The seniority list shall be without prejudice to the final outcome of Writ Petition(s), if any, pending in the Competent Court(s) of Law.


