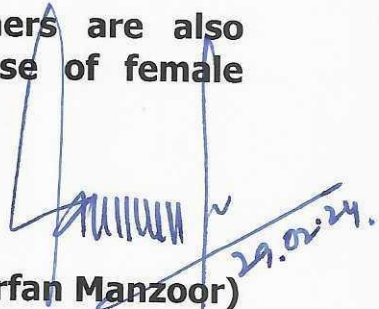
NOTICE

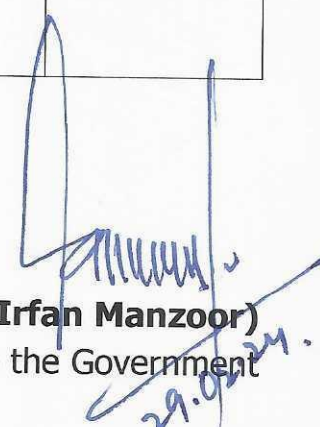
