Pursuant to the repeal of Jammu and Kashmir State Vigilance Commission Act, 2011 in terms of the Jammu and Kashmir Reorganization (Adaptation of State Laws) Order, 2020, sanction is hereby accorded to the winding up of Jammu and Kashmir Vigilance Commission.


Consequent upon above, it is hereby ordered as under:

- (i) All the staff posted in the Jammu and Kashmir Vigilance Commission drawn from various Departments shown in **Annexure-A** to this order shall report to the concerned Administrative Department indicated against each.
- (ii) The staff posted/deployed in Jammu and Kashmir Vigilance Commission by the General Administration Department drawn from various Corporations/PSUs/ Organizations shown in **Annexure-B** to this order shall report to the Department/Organization indicated against each.
- (iii) A committee comprising of Financial Advisor/CAO & Under Secretary posted in Jammu and Kashmir Vigilance Commission shall handover the records, electronic equipments, books and other miscellaneous items of Jammu and Kashmir Vigilance Commission to the Director, Anti Corruption Bureau, J&K, who shall ensure safe custody of the records.



- (iv) The above referred Committee shall also handover building housing the Commission alongwith furniture to Director, Estates, J&K. Besides, the Genset (02 Nos) purchased by the Commission from time to time shall also be handed over to the Director, Estates, J&K by the Committee.




