Consequent upon the repeal of the Jammu and Kashmir State Forest Corporation Act, 1978 under the Jammu and Kashmir Reorganization (Adaption of State Laws) Order, 2020 dated 31st March, 2020, and ceasing of the Jammu and Kashmir State Forest Corporation as such from 31st March, 2020, sanction is hereby accorded to the creation of company namely "Jammu and Kashmir Forest Development Corporation" (hereinafter referred to as J&K FDC), with all the assets and liabilities of the J&K State Forest Corporation as on 31st March, 2020, under the Companies Act, 2013.

Further, it is ordered that:-

- i) The authorized share capital of the J&KFDC shall be Rs. 10,00,00,000 (Rs. Ten Crores) divided into Rs. 1,00,000 (One lac) equity shares of Rs. 1000 (Rupees one thousand) each. All shares except two shall be held by the Hon'ble Lieutenant Governor of Union territory of Jammu and Kashmir. One share each shall be held by the Administrative Secretary of Department of Forest, Ecology and Environment and Administrative Secretary of the Finance Department.
- ii) The Board of Directors of J&K Forest Development Corporation shall comprise of the following:-
