Subject: Re-fixation of seniority of the members of J&K Excise and Taxation (Gazetted) Service in the Jammu and Kashmir Administrative Service (JKAS).

**Government Order No.984–JK(GAD) of 2021,
Dated:23-09-2021.**

WHEREAS, among others, the following four members of the J&K Excise and Taxation (Gazetted) Service were appointed to the Time Scale of JKAS vide Government Order No. 88-GAD of 2011 dated 14.01.2011 prospectively:

- (i) Mr. Abdul Qayoom Ahangar (now retired)
- (ii) Mr. Pawan Kumar
- (iii) Mr. Bharat Singh
- (iv) Mr. Mansoor Aslam Choudhary;

AND WHEREAS, these officers represented for review of their appointment, by modification in the date of appointment w.e.f 06.12.2010 i.e. the date on which the Establishment-cum-Selection Committee (ECSC) made recommendations for their appointment to the Time Scale, instead of 14.01.2011;

AND WHEREAS, the ECSC upon consideration of the issue, in its meeting held on 19.02.2015, recommended to modify the date of appointment to the Time Scale of these officers and upon acceptance of these recommendations by the State Cabinet in its meeting held on 19.4.2015, vide Government Order No. 569-GAD of 2015 dated 19.4.2015, the appointment of these officers was modified and given effect from 06.12.2010 instead of 14.01.2011;

AND WHEREAS, consequent upon the issuance of aforesaid Government Order No. 569-GAD of 2015 dated 19.4.2015, the seniority position of these officers had to be refixed in the
