Subject: Fixation of seniority of Mr. Ghulam Rasool in the Jammu and Kashmir Administrative Service (JKAS).

**Government Order No.985–JK(GAD) of 2021,
Dated:23-09-2021.**

WHEREAS, Mr. Ghulam Rasool, a direct recruit of 2001 batch allotted to J&K Revenue (G) Service, could not be appointed to the Time Scale of KAS, during 2011, alongwith the other members of his service, on account of pending vigilance clearance;

AND WHEREAS, the Establishment-cum-Selection Committee in its meeting dated 24.08.2012, while assessing the officer, decided to adopt "Sealed Cover Procedure", in terms of Article 110-A(2) of J&K CSRs;

AND WHEREAS, the case of the officer was reviewed by the Establishment-cum-Selection Committee in its meeting dated 20.10.2015 and on the basis of assessment already made by the Committee on 24.8.2012, it was recommended to appoint Mr. Ghulam Rasool to the Time Scale of JKAS, on adhoc basis;

AND WHEREAS, the above recommendations of the Committee were accepted by the State Cabinet in its meeting dated 02.12.2015 and accordingly, Mr. Ghulam Rasool was appointed to the Time Scale of JKAS, on adhoc basis, vide Government Order No. 1506-GAD of 2015 dated 02.12.2015;

AND WHEREAS, vide order dated 10.04.2013, the Hon'ble Court of Additional Judge Anti-corruption, Jammu framed charges against the accused persons including Mr. Ghulam Rasool and the said order was challenged before the Hon'ble High Court of Jammu and Kashmir, which vide its judgment dated 16.10.2018 set aside the order of the trial court. The judgment of the Hon'ble High

Court has been accepted as final by the Anti-corruption Bureau, J&K on 04.07.2019;

AND WHEREAS, consequent upon exoneration of the charges, the case of the officer was considered by the ECSC in terms of Article 110-A of J&K CSRs read with Rule 8(2) of JKAS Rules, 2008, in its meeting held on 29.7.2021 and recommended for regular appointment into the Time Scale of JKAS;

AND WHEREAS, pursuant to the acceptance of above recommendations of Establishment-cum-Selection Committee, Mr. Ghulam Rasool has been appointed to Time Scale of JKAS, notionally from 28.12.2011 and on regular basis from 02.12.2015, vide Government Order No. 757-JK(GAD) of 2021 dated 18.08.2021;

AND WHEREAS, consequent upon the issuance of aforesaid Government Order No. 757-JK(GAD) of 2021 dated 18.08.2021, Mr. Ghulam Rasool had to be assigned seniority position at S. No. 89-A, below Mr. Malikzada Sheraz Ul Haq (S. No. 89) and above Mr. Ghanshyam Singh (S. No. 90) in the seniority list of JKAS officers issued vide Government Order No. 784-GAD of 2014 dated 18.7.2014.;

AND WHEREAS, the members of JKAS whose seniority would get altered because of fixation of seniority of Mr. Ghulam Rasool at S. No. 89-A were asked to submit their objections, if any, within a period of 21 days from the date of issuance of notice dated 20.08.2021;

AND WHEREAS, none of the officers of JKAS objected to the fixation of seniority of Mr. Ghulam Rasool at S. No. 89-A in the seniority list of JKAS officers issued vide Government Order No. 784-GAD of 2014 dated 18.7.2014.

NOW, THEREFORE, it is hereby ordered that Mr. Ghulam Rasool, JKAS, Deputy Director, Handlooms (Administration) in the Directorate of Handlooms Department, J&K, shall and shall always be deemed to have figured at S. No. 89-A in the seniority list of JKAS officers issued vide Government Order No. 784-GAD of 2014 dated 18.7.2014, below Mr. Malikzada Sheraz-ul-Haq (S. No. 89) and above Mr. Ghanshyam Singh (S. No. 90).
