Subject: Fixation of seniority of members of J&K Rural Development (Gazetted) Service, in the Jammu and Kashmir Administrative Service.

WHEREAS, among others, the following officers of the J&K Rural Development (G) Service could not be considered for induction into the Time Scale of JKAS alongwith other members including their juniors, due to involvement in FIR No. 18/2005 and 19/2005 registered in the P/S VoK and accord of sanction for prosecution in terms of Government Order No. 36-GAD(Vig) of 2012 dated 5.10.2012 and 37-GAD(Vig) of 2012 dated 5.10.2012:

- (ii) Mr. Bashir Ahmad Hajam (now retired)
- (iii) Mr. Fayaz Ahmad Bhat (now retired)
- (iv) Hakeem Tanveer Ahmad

AND WHEREAS, the Hon'ble High Court, vide judgment dated 16.08.2018 quashed the sanction for prosecution in respect of these officers as also the FIRs bearing No. 18/2005 and 19/2005 registered by P/S VoK. The decision of the Hon'ble Court was accepted as final by the Anti-Corruption Bureau;

AND WHEREAS, consequent upon the exoneration of charges leveled and upon acceptance of the recommendations of the Establishment-cum-Selection Committee by the competent authority, these officers were appointed to the Time Scale of JKAS from the dates indicated against each:
