1. Whereas, this Department vide Notification No.01 of 2022 dated 27.12.2022, invited applications for hiring of 01 Supervisor and 06 operators(s) under Centrally Sponsored Scheme for "Emergency Response Support System";
2. Whereas, a total 964 No. of applications (Supervisor=130 + Operator= 834) were received within the prescribed time limit. Out of which, the applications of 15 and 90 candidates were found eligible for interview of Supervisor and Operator positions respectively.
3. Consequent to the above, the interview venue was fixed in both the divisions of UT of J&K in two phases and the interview was conducted at both the places as under:-
 - a) Phase I (Jammu Based candidates) at Jammu on 06.02.2023.
 - b) Phase II (Kashmir Based Candidates) at Srinagar on 08.02.2023.
4. Accordingly, based on the highest overall merit obtained for the position of Operator, **Sanction is hereby accorded to the hiring of 04 Operator(s)**, under Centrally Sponsored Scheme for "Emergency Response Support System". The details of the hired candidate(s) are as under:-

5. The terms and conditions of the hiring of Operator(s) under Centrally Sponsored Scheme for "Emergency Response Support System" are as under:-

- I. Hiring is initially for a period of 12 months which may be extended upto 36 months from the date of joining in the Department of Disaster Management, Relief, Rehabilitation & Reconstruction or the completion of the project, whichever is earlier, on the consolidated pay of Rs. 18000/month.
- II. The selected candidate(s) from:-
 - (a) Kashmir Division shall report in the office of the Secretary to the Government, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Civil Secretariat, Srinagar (Room No.125 First Floor) &
 - (b) Jammu Division shall report in the office of the Under Secretary to the Government, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Civil Secretariat, Jammu (Room No.3/37-D).
- III. Further, the hired candidates shall report within a period of 10 days from the date of issuance of this hiring order and in case of failure to join within stipulated time period, the hiring order shall be deemed to have been

cancelled without any further notice and the next candidate in the order of merit list shall be called to fill up the post.

- IV. The hired candidate(s) for the position of Operators shall have to execute an agreement before the First Class Magistrate with the condition that they will work in the department as found fit by the appointing authority and will not claim any continuation/regularization/absorption in the Department of Disaster Management, Relief, and Rehabilitation & Reconstruction.
