**Government Order No. 31 - JK(DMRRR) of 2023  
Dated: 24.05.2023.**

- (i) Whereas D/o DMRRR issued notification vide endorsement No.DMRRR-ER/76/2021 dated 24.01.2022 followed by extension dated 09.02.2022 for closure of the scheme of One Time Financial Assistance to Displaced Persons of POJK (1947) and Chhamb (1965 & 1971) of Jammu & Kashmir and for filling claims in the offices of Designated Authorities till 05.03.2022.
- (ii) Thereafter, D/o DMRRR vide no. No.DMRRR- ER/76/2021 dated 12.07.2022 followed by a reminder letter dated 09.12.2022, after approval of competent authority requested Ministry of Home Affairs to extend the timeline of the scheme of One Time Financial Assistance to Displaced Persons of POJK (1947) and Chhamb (1965 & 1971) of Jammu & Kashmir.
- (iii) Consequent to the above, Ministry of Home Affairs, Gol, Department of Jammu, Kashmir & Ladakh Affairs vide communication No.15030/99/2020-J&K Dated: 03.05.2023 has conveyed extension to the timeline of the scheme, Central Assistance for one time settlement of displaced families of POJK (1947) and Chhamb (1965 & 1971) settled in the Jammu & Kashmir, from 31/03/2022 to 31/03/2024 under the Rehabilitation Package approved by the Cabinet on 30.11.2016.

Accordingly, sanction is hereby accorded to the extension of the scheme, Central Assistance for one time settlement of displaced families of POJK (1947) and Chhamb (1965 & 1971) settled in the Jammu & Kashmir, from 31/03/2022 to 31/03/2024 with the approved outlay of Rs, 2000 Cr. with the stipulation that the scheme shall not continue beyond the sunset date of 31.03.2024.


