Terms of Reference:

- To identify areas for the formulation of new Indian Standards.
- To identify products, processes and system for enforcing compliance with Indian Standards.
- To implement measures for effective implementation of Quality Control Orders (QCOs) issued by Government of India.
- To take measures for awareness generation among consumers regarding standards.
- Any other activity to create a robust eco-system in the Union territory.

It is further ordered that the representatives of Non- Government Organizations/Bodies shall be nominated by the Chairman of the UTLCS and the term of their engagement shall be three years. They can however be re-nominated. The Committee shall meet at least twice a year, and as many more times, as deemed fit by the Chairman.

Further, heads of the BIS, Jammu & Kashmir Branch Office, Northern Regional Office shall provide necessary support to the Member Secretary to convene the meetings and take follow-up action on the decisions taken in them. Head of the BIS Jammu & Kashmir Branch Office, Northern Regional Office shall be the Nodal Branch Officer for this purpose.
