Terms of Reference:

i. To identify areas for the formulation of new Indian Standards.

ii. To identify products, processes and system for enforcing compliance with Indian Standards.

iii. To implement measures for effective implementation of Quality Control Orders (QCOs) issued by Government of India.

iv. To take measures for awareness generation among consumers regarding standards.

v. Any other activity to create a robust eco-system in the Union territory.

It is further ordered that the representatives of Non- Government Organizations/Bodies shall be nominated by the Chairman of the UTLCS and the term of their engagement shall be three years. They can however be renominated. The Committee shall meet at least twice a year, and as many more times, as deemed fit by the Chairman.



Further, heads of the BIS, Jammu & Kashmir Branch Office, Northern Regional Office shall provide necessary support to the Member Secretary to convene the meetings and take follow-up action on the decisions taken in them. Head of the BIS Jammu & Kashmir Branch Office, Northern Regional Office shall be the Nodal Branch Officer for this purpose.
