**Government Order No. 1359 -JK(GAD) of 2023**

**Dated: 08.11.2023**

I. In partial modification of Government Order No. 1349- JK(GAD) of 2023 dated 07.11.2023, it is hereby ordered that :

- a. Committee constituted under point 'C' shall be designated as Committee for Other Districts/Towns (for population between 1 to 10 lacs)
- b. Committee constituted under Point 'D' shall be designated as Committee for other towns.
- c. Representatives from Agriculture and Farmers Welfare Department, Cooperatives Department and Fertilizers and Oil Companies shall also be members of the Committees mentioned at point B, C, D and E.


II. Further, following instructions are hereby notified for smooth conduct of the Viksit Bharat Sankalp Yatra :

**a. Establishment of Control Rooms at UT Level and District Level :**

- i. **UT Level Control Room-** Planning Development and Monitoring Department shall establish control room at the UT Level for overall coordination during the campaign.
- ii. **District Level Control Room-** The Districts shall establish Control rooms under the overall supervision of Deputy Commissioner assisted by senior officers along with Assistant Commissioner, Development as the Nodal Officer.

b. Committees constituted for the Viksit Bharat Sampark Yatra shall be responsible for overall supervision of the campaign and shall lay special emphasis on the reconciliation of data regarding various focus schemes illustrated at para (i) below, during the campaign.

c. District Level Committee under the guidance and instructions of Deputy Commissioners, shall establish liaison with Government of India for




reconciliation of data, wherever required, for the schemes under implementation, within their respective district.

- d. Panchayat Level Convergence Committee constituted vide Government Order No. 172-GAD of 2019 dated 05.02.2019 shall act as the Nodal committee at the panchayat level. The Committee shall include representatives/members from all line departments.
- e. The Deputy Commissioners shall finalize the Route plan for the campaign and submit the same to the respective Divisional Commissioner(s). The plans shall also be shared with District Superintendent of Police and Planning Development and Monitoring Department as well. The campaign shall be planned in such a manner that one Van should cover two panchayats in a single day.
- f. Every District shall notify orders for the '**Van Nodal Officer**' as well as '**Day Nodal Officer**' for the campaign.
- g. All Districts shall prepare e-compendium of every Panchayat for the Campaign.
- h. Under the Meri Kahaani Meri Zubani Campaign, which is an integral constituent of this Yatra, interviews of atleast **10 beneficiaries per panchayat** and **05 beneficiaries per ward** of various scheme of Government shall be recorded and uploaded. It shall be ensured that the good quality videos are captured and submitted to the District level Committee which shall be uploaded by the NIC Team in coordination with Directorate of Information and Public Relations (DIPR) Department on the Viksit Bharat Yatra Portal of Government of India. Deputy Commissioner shall monitor the overall uploading of videos and information on the portal. The Information Technology Department and DIPR shall issue necessary directions to NIC and DIOs.
- i. The Focus schemes during the campaign shall be on the following schemes of the sectors mentioned below :
