**Subject: Setting up of Centre for Transformation and Innovation in Governance (CTIG) in J&K-Constitution of Committee thereof.**

**Government Order No. 34 -JK(GAD) of 2024**

**Dated: 04.01.2024**

Sanction is hereby accorded to constitution of a committee, comprising the following, for preparing draft MoU to be signed with IIM Jammu/other knowledge partners with regard to establishment of Centre for Transformation and Innovation in Governance (CTIG), in the Union territory of Jammu & Kashmir :-

01	Administrative Secretary, Finance Department.
02	Administrative Secretary, Information Technology Department.
03	Administrative Secretary, Planning, Development and Monitoring Department.
04	Administrative Secretary, Department of Law, Justice and Parliamentary Affairs.

**Terms of Reference:-**

1. To prepare a draft MoU which shall be signed between IIM Jammu as anchoring knowledge partner, and Planning Department after mutually agreed terms.
2. IIM Jammu shall be knowledge partner for setting-up of "Centre for Transformation and Innovation in Governance in J&K" which shall involve experts/ advisors/ consultants/retailer consultants/ researchers/ interns etc for undertaking various activities in different domains/ priority areas. IIM Jammu may collaborate with other knowledge partners such as IIT Jammu, SKUAST Kashmir, IUUST, BISAG etc to achieve the desired end results, as defined by the Government from time to time.
3. Priority areas shall be defined by the Government, which inter-alia include Holistic Development in Agriculture Sector, Creation of more Micro-enterprises and facilitating them to become small and medium enterprises, Strengthening of Cooperative Sector and Skill Development, working on some niche areas, identify atleast 10 new Tourist destinations each in Jammu and Kashmir division(s) and develop them into world famous destinations through creation of necessary infrastructure, credit flow availability/ utilization, Contract Management, Monitoring and Evaluation, Expanding Employment, Revival of PSUs, Cooperative Society etc.
4. The draft MoU should clearly define Nucleus (Group of Institutions), Continuity in Knowledge sharing, Cost involved and Outcomes expected (Predefined Outcomes) as well as clearly spell-out roles and responsibilities of each partner.
5. Further, hand holding/ assistance can be taken from BISAG- N Ahmedabad where ever required for which Team of experts from BISAG can be embedded in IIM Jammu.

6. Setting-up of "Centre for Transformation and Innovation in Governance in J&K" (CTIG) which shall address all the concerns/ activities being proposed earlier proposed under State Institute of Transformation (SIT), Public Private Partnership (PPP) expert cell and Future Ready Governance (FRG) unit besides other issues under one Umbrella i.e CTIG .

The Committee shall be serviced by the Planning Development and Monitoring Department and shall submit the finalised draft MoU for approval of the Competent Authority.
