  - b) Salary of the appointee(s) shall not be drawn and disbursed to them unless and until the final character and antecedents verification/report is received from CID through EVS portal and a satisfactory report/genuineness of the certificates in respect of Condition i (a) is also received from the concerned issuing authority.
  - c) The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
  - d) Appointee/s shall abide by all the terms and conditions as laid down in his/her appointment order.
  - e) The appointee(s) shall be on probation for a period of two (02) years.
  - f) Appointee(s) have no criminal records and also is not facing any criminal proceedings in any Court of Law.
  - g) Appointee(s) shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the appointment order.
- ii) The inter-se-seniority of the appointee(s) shall be drawn in accordance with the merit secured by the appointee(s) in the selection list prepared by the Service selection Board.
- The orders issued are without prejudice to the outcome of any petition pending before any competent court of law/Tribunal etc.
- That the appointment of the candidate is based on the provisional character and antecedents verification received from the CID. If any adverse report is received during the finality of the character and antecedents verification process through EVS portal as per standing Government orders on the subject, the appointment shall be deemed to have been cancelled ab-initio.
