On the recommendations of the J&K Service Selection Board and communicated by the Administrative Department vide communication referred above, sanction is hereby accorded to the appointment of Sumeet Kumar S/o Rakh Pal R/o H.No.01, Ward No. 19,Rajpura, Mangotrian, Jammu under OM category as Driver-II in the Department of Horticulture, Jammu in the Pay Level-2 (19900-63200), in District Cadre with immediate effect.

The appointee shall report to the Chief Horticulture Officer, Jammu within a period of twenty one (21) days from the date of issuance of this order and in case, he fails to join within the stipulated time, he shall forego his right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates in original to be verified by the concerned Controlling Officer/Drawing & Disbursing officer subsequently:-

- 1. Academic/Technical Qualification Certificate.
- 2. Matriculation / Date of Birth Certificate.
- 3. Health Certificate from the concerned Chief Medical Officer of the District.
- 4. Domicile Certificate issued by the competent authority.
- 5. Reserved Category Certificate, where applicable.
- 6. Any other relevant document(s) if required.

The appointment of the above candidate shall further be subject to the following conditions:-

- i. The appointee shall give an undertaking in the shape of an affidavit to the effect that:-
- a. If on verification his qualification/ date of birth/ reserved category certificate are found forged, false or fake by concerned issuing authorities, the appointment as Driver-II in the Department of Horticulture Jammu shall be deemed to have been cancelled ab-initio and legal action as warranted under rule shall be initiated against him.

- b. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centres, he shall relinquish the proprietorship of the firm/unit and also its stake, if any, in such self-employment units/enterprises before joining the Government Service. He shall be require to re-pay the entire loan/liability in suitable EMIs to be worked out by the DDO concerned from his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment units/enterprises and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth and Relevant category Certificates are received from the concerned authorities/agencies.
- i. The appointee shall be on probation for a period of 02 years.
- ii. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- iii. If by any chance candidate who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he will be liable for cancellation of selection and criminal prosecution as well in light of the Judgement rendered by the Hon'ble Supreme Court;
- iv. The inter-se seniority of the appointee shall be as per the merit as it exists in the selection list prepared by the J&K Service Selection Board:
- v. The appointment shall be subject to outcome of the writ petition (s) / O.A, if any pending in any competent court/Tribunal;

vi. The cadre/department allocated by appointing authority/SSB shall not be changed under any circumstances;
