Sanction is hereby accorded to the temporary appointment of Mr. Rabinder Singh 5/o Inderject Singh (deceased Senior Lecturer, BHSS Teetwal Karnah, Kupwara who died in harness on 15-05-2021) R/o Dildar Tehsil Karnah, District Kupwara Qualification: 10+2 as Multitasking Staff (Laboratory Bearer), in the Pay Level-SL-1 (14800-47100) against an available post of MTS (Direct quota) in District Kupwara, UT of J&K, on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer Kupwara within a period of 21 days from the date of issuance of this Order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:

1. Academic Qualification Certificate.

- Date of Birth Certificate/ Matriculation Certificate.
- 3. Domicile Certificate issued by the competent authority.
- 4. Health Certificate from the concerned Chief Medical Officer of the District.

Dependent Certificate issued by the Competent Authority.

- No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- All other relevant documents as are required under SRO-43/1994.

The appointment of the candidate shall further be subject to the following conditions; that:

- a. He shall give an undertaking in the shape of an affidavit to the effect that;
 - i. There is no criminal record against the appointee.
 - ii. If, on verification, genuineness of the qualification certificates/ Date of Birth/ Dependent Certificate and other certificates/ documents from the concerned issuing authority is/ are found fake/ forged, the appointment made shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect (i) and (ii) above are received in his favour from the Competent Authority.

c. The appointee shall be initially on probation for a period of two years.

- d. The appointment of the candidate shall be governed by the "New Pension Scheme" (NPS) as per SRO-400 of 2009, dated: 24-12-2009.
- e. If the appointee fails to join within a period of 21 days from the date of issuance of this Order, he shall cease his right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.

f. The appointment shall be subject to outcome of writ petition(s), if any, pending in any Competent Court/ Tribunal etc.
