## **Terms of reference:**

- i. The committee shall examine and provide technical vetting of the DPRs/project proposals as per procedure laid down in the General Financial Rules, 2017/CVC guidelines and guidelines issued by the Ministry of Renewable Energy, GoI and furnish recommendations regarding the provisions proposed in DPR.
- ii. The committee shall examine and technically vet all the components of the DPR including design, rates, technology adopted etc.
- iii. The committee shall also furnish recommendations/suggestions on the viability of the proposed solutions in the DPR, if any, along-with estimated cost.
- iv. The committee shall ensure strict compliance to all the rules, procedures/guidelines issued by Government from time to time while vetting the DPRs.
