Subject:- Extension of the timeline of the scheme, Central Assistance for one time settlement of displaced families of PoJK(1947) and Chhamb (1965 and 1971) settled in the Jammu and Kashmir from 31.03.2024 to 31.03.2025 under the Rehabilitation Package approved by Cabinet on 30.11.2016.

- i. Whereas, D/o DMRRR issued notification vide endorsement No. DMRRR-ER/76/2021 dated 24.01.2022 and 09.02.2022 followed by extension dated 13.02.2024 in respect of One Time Financial Assistance to Displaced Persons of POJK (1947) and Chhamb (1965 & 1971) of Jammu and Kashmir and for filling of claims in the offices of Designated Authorities till 29.02.2024
- ii. Thereafter, D/o DMRRR vide No. DMRRR-ER/76/2021 dated: 26.02.2024, after approval of competent authority requested Ministry of Home Affairs to extend the timeline of the scheme of One Time Financial Assistance to Displaced Persons of POJK (1947) and Chhamb (1965 & 1971) of Jammu & Kashmir so that pending eligible beneficiaries can avail the scheme.
- iii. Consequent to the above, Ministry of Home Affairs, GoI, Department of Jammu, Kashmir and Ladakh Affairs vide communication No. 15030/99/2020-J&K Dated 14.03.2024, has conveyed extension to the timeline of the scheme, Central

Assistance for One time settlement of displaced families of PoJK (1947) and Chhamb (1965 & 1971) settled in the Jammu and Kashmir from 31.03.2024 to 31.03.2025 under the Rehabilitation package approved by Cabinet on 30.11.2016.

Accordingly, sanction is hereby accorded to the extension of the scheme, Central Assistance for one time settlement of displaced families of PoJK (1947) and Chhamb (1965 & 1971) settled in Jammu & Kashmir, from 31.03.2024 to 31.03.2025 within the approved outlay of Rs. 2000 Crore with the stipulation that the scheme shall not continue beyond sunset date i.e 31.03.2025.


