Subject: Correction in name/service records of Shri Sachin Kumar Vaishy, IAS.

Government Order No. 873-JK(GAD) of 2024.

WHEREAS, Mr. Sachin Kumar Vaishy, IAS (AGMUT:2015), Deputy Commissioner, Jammu submitted a representation for correction of his name from "Shri Sachin Kumar **Vaishy**" to "Shri Sachin Kumar **Vaishya**" in his service records.

AND WHEREAS, Department of Personnel & Training, Government of India vide Office Memorandum No. 19016/1/87-Estt(A) dated 12.03.1987, has notified the procedure for change of name by Government employees. The Clause I of the ibid O.M. reads as under:-

A Government employee wishing to adopt a new name or to effect any modification in his/her existing name may do so, formally by a deed changing his/her name. The same deed form is enclosed.

The execution of the deed should be followed by publication of the change in prominent local newspaper as well as in the Gazette of India at the Government employee's own expense.

AND WHEREAS, Shri Sachin Kumar Vaishay, IAS has executed the requisite deed and notice about correction in his name has been published in the Government Gazette of India;

AND WHEREAS, the matter was then taken up the Ministry of Home Affairs, vide this department's letter dated 02.01.2024 for consideration of the request of the officer regarding change of his name as "Sachin Kumar Vaishya" from "Sachin Kumar Vaishy" in his service record;

AND WHEREAS, the Department of Personnel & Training, Government of India vide Notification dated 13.02.2024, addressed to the Manager, Government of India Press, Minto Road, New Delhi and among others copy endorsed to the Government of Jammu and Kashmir has permitted Shri Sachin Kumar Vaishy, IAS (AGMUT:2015) to change his name from "Sachin Kumar **Vaishy**" to "Shri Sachin Kumar **Vaishya**" and he will accordingly be recognized as "Shri Sachin Kumar Vaishya" for all official purposes;
