The term of office of the non-official members of the Biodiversity Council shall be for a period of three years from the date of issuance of this order.

## Terms of Reference(s):-

- 1. The Council shall function as per the provisions of the Biological Diversity Act, 2002 (Central Act 18 of 2003) and Biological Diversity Rules, 2004.
- 2. The Council shall constitute the "Jammu and Kashmir Biodiversity Council Fund", after seeking prior concurrence of the Finance Department, and there shall be credited thereto all the fees, sums, charges and benefits-sharing amount.
- 3. The Jammu and Kashmir Biodiversity Council Fund shall be utilized only for the purposes provided for in terms of Section 27(2) of Biological Diversity Act, 2002.
- 4. The Council shall perform such functions within the jurisdiction of the Union territory of Jammu and Kashmir, as have been vested to the State Biodiversity Boards, under various provisions of the Biological Diversity Act, 2002.
- 5. The Council shall, in consultation with the National Biodiversity Authority, notify the format and procedures for seeking approvals as required under Section 7 of the Act.
