 - b. National Broadband Mission.
 - c. Comprehensive & Sustainable Mobility Plan (CSMP)

2. To identify the bottlenecks in the implementation of schemes and suggest measures for timely resolution.
3. To ensure coordination amongst the stakeholders for faster resolution of issues like land allocation (Revenue/Forest), Right of Way (RoW) permission, power grid connection to mobile towers etc.
