Subject: Availability of staff at Civil Secretariat, Srinagar and Jammu.

## Government Order No.978-JK (GAD) of 2024 Dated:27.04.2024

For effective and efficient conduct of official business at Civil Secretariat, Srinagar and Jammu, it is hereby ordered that:

- 1. The Civil Secretariat shall continue to remain functional at both places and the Administrative Secretaries shall ensure arrangements for smooth functioning of offices at both places viz; Srinagar and Jammu.
- The Administrative Secretaries shall ensure their availability at Civil Secretariat, Srinagar w.e.f. <u>1<sup>st</sup> May</u>, <u>2024</u>. However, they will attend the Civil Secretariat, Jammu, as per the functional requirement.
- The arrangements with regard to availability of staff of Administrative Departments of Civil Secretariat shall be determined by the respective Departments, ensuring smooth conduct of official business at both places, with bare minimum shifting of staff.
- 4. The Estates Department, upon requisition by the concerned Administrative Departments shall provide accommodation to the officers/officials, as per requirement, only where necessary.
