**Terms of reference:**

- i. To monitor the implementation of the Jammu and Kashmir Road Safety Policy-2025 across the Union Territory, including review of progress made by the concerned Departments and agencies in achieving the objectives of the Policy.
- ii. To review and recommend engineering and road safety measures for improving road infrastructure, traffic management, signage, road markings and other interventions.
- iii. To identify black spots/hotspots and formulate an action plan for their rectification, in coordination with the concerned executing agencies and to periodically review the status of these remedial measures.
- iv. To review the planning, implementation and operationalisation of Integrated Traffic Management Systems (ITMS)/Intelligent Traffic Light Systems (ITLS) in Jammu and Srinagar cities and their expansion to other towns of the Union Territory.
- v. To make such recommendations as may be necessary for strengthening road safety management and improving emergency response to road accidents in the Union Territory.

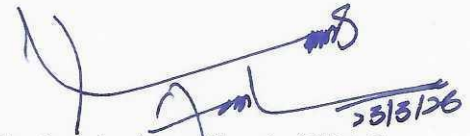
