Subject: Compassionate appointment of Ms. Zahida Banoo D/o Sh. Ghulam Hassan Lone & W/o Late Sh. Irshad Ahmad, Ex-Teacher, School Education Department, R/o Mangota, Tehsil Marmat, District Doda, under Jammu & Kashmir Rehabilitation Assistance Scheme-2022, for the **Calendar Year 2024**.

Reference: Satisfactory Character and Antecedents report received from Criminal Investigation Department, J&K vide Form No. 147082 dated 28.02.2026.

Sanction is hereby accorded to the temporary appointment of Ms. Zahida Banoo D/o Sh. Ghulam Hassan Lone & W/o Late Sh. Irshad Ahmad, Ex-Teacher, School Education Department, R/o Mangota, Tehsil Marmat, District Doda, as Class-IV (Multitasking Staff), in the Pay Level SL-1 (14800-47100), Divisional Cadre Jammu, Government Medical College, Doda, in Health & Medical Education Department J&K, in relaxation of upper age bar, in terms of Clause-3(d) of the Jammu & Kashmir Rehabilitation Assistance Scheme-2022 .


The appointee shall report to the Administrative Secretary, Health & Medical Education Department, J&K, within a period of 21 days from the date of issuance of this order, failing which she shall forego her right to appointment and the same shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently: -

- i. Academic Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate.
- v. All other relevant documents as are required under Jammu & Kashmir Rehabilitation Assistance Scheme-2022.

The appointment of the appointee shall further be subject to the following conditions: -

- a. That applicant shall give an undertaking in writing, as per format prescribed in the Scheme, that she shall maintain properly the other family members who were dependent on the deceased and in case, it is proved subsequently, at any time that the family members are being neglected or are not being maintained properly by her, appointment shall be cancelled forthwith.
- b. Any claim for transfer of appointment to any other family member shall invariably be rejected.
- c. The appointee shall be adjusted against appropriate category to which she belongs. In case, the appointee fails to produce any valid category certificate, she shall be adjusted against General Category.
- d. That she shall give an undertaking in the shape of an Affidavit to the effect that if on verification, her Qualification / Date of Birth / Category Certificates, if any, from the concerned issuing authority are found to be fake/forged, the claim of the appointee for appointment as 'Class-IV (Multitasking Staff)', shall be deemed to have been cancelled *ab-initio* and legal action as warranted under rules shall be initiated against her.
- e. That she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate First Class, to the effect that the applicant is un-employed as on date and none of the family members other than the applicant has taken benefit of compassionate appointment under J&K Rehabilitation Assistance Scheme-2022. In case, it turns out that the applicant is already appointed or the benefit of

compassionate appointment under the Scheme has already been extended to the family member of deceased, then the instant appointment shall be deemed to have been withdrawn ab-initio without any further notice.

- f. That if the candidate has taken loan for self-employment from District Industries Centre (DIC) / Employment Department, to be ascertained from the DIC and District Employment & Counseling Centre of the domicile District, she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the Drawing & Disbursing Officer concerned from her salary. The Drawing & Disbursing Officer concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- g. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of genuineness of Qualification/Date of Birth/Category Certificate, if any, is received from the concerned authorities.
- h. The appointee shall be on probation for a period of two years.
- i. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- j. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before competent Court of law.


