Terms of Reference:

- i. To examine the Acts, Rules, Regulations, Government Orders, Circulars, Notifications, Policies and other relevant documents.

- ii. To suggest way forward for repealing/amending these laws based on following outcomes:
 - a. Change of approvals/licenses to self-registration;
 - b. Lifetime validity of all licenses; any periodic fee to be paid can be separated from license validity; inspections by department or third party to amend or revoke license if critical conditions are not met;
 - c. Regulations must only target desired outcomes and not specify processes;
 - d. Allowing qualified Independent Third Parties to conduct inspections;
 - e. Repeal of outdated or redundant laws.
- iii. To propose the draft of the Right to Business Bill based on aforesaid principles.

The Committee shall submit its recommendations within a period of one month from the date of issuance of the order.
